

Terms and Conditions for participation in Marquee Matches

1. Submissions for Marquee Matches may be done via an online RSVP form ("Form") prior to the Marquee Valentine's Day event ("Event"), or a love profile card ("Card") at the Marquee Matches booth at the Event. By making a submission, you agree to be bound by these Terms and Conditions. If you disagree with any part of the Terms and Conditions, please do not make a submission for Marquee Matches.

Submissions

2. You are only allowed to make one (1) submission for Marquee Matches, whether through a Form or Card, and it must be for yourself. Multiple submissions or submissions on behalf of other parties are not allowed.
3. You are responsible for ensuring that all information submitted in the Form or Card is truthful and accurate. The particulars and information provided in all submissions will be accepted by Marina Bay Sands Pte Ltd ("MBS") and Marquee in good faith and we rely on participants to keep us updated of any changes. MBS and Marquee are not responsible for verifying any information provided.
4. Online submissions will close at 12pm on 12 February 2026. Submissions made after this time will not be accepted, although you will be able to make submissions via the Card at the Marquee Matches booth at the Event.
5. Submissions of the Card at the Marquee Matches booth must be made during the Event by no later than 12:30am.
6. Submissions will be disqualified if, as determined by MBS in its sole discretion:
 - a) you tampered or attempted to tamper with the entry process/operation/ outcome of Marquee Matches;
 - b) you manipulated or attempted to manipulate the entry process/operation/ outcome of Marquee Matches;
 - c) your entry features any nudity or obscene or inappropriate language or material that is libelous or defamatory or infringes any third party rights;
 - d) you have provided false information (such as inaccurate answers, fake accounts or personas) or have deliberately withheld information;
 - e) your conduct is in breach of the Terms and Conditions.
7. Please note that the information submitted via the Form or Card, including but not limited to your name, Instagram Handle, age, height, favourite music, star sign, love language, fun fact(s) about you, your type and sexual orientation, may be openly displayed at the Marquee Matches booth. If you are not agreeable to this, please do not make a submission for Marquee Matches.

Selection of participants

8. Submissions will be selected based on the creativity and thoughtfulness of the answers provided in the Form or Card.

9. For online submissions, you will be informed no later than 6pm on 13 February 2026 via Instagram DM to the account provided in the Form, if you are selected for participation in Marquee Matches at the Event (“Selected Participant”). Please note that for online submissions, there will only be up to 5 Selected Participants. Selected Participants will also be eligible to receive complimentary entry to Marquee on the Event date. Please respond to the DM with your name to be placed on the guestlist.
10. For submissions made at the Marquee Matches booth, Selected Participants will be contacted via the Instagram DM to the account provided on the Card. Please note that only up to 5 submissions made at the booth will be selected for participation in Marquee Matches. Entry to Marquee on the Event date is at your own cost.
11. All Selected Participants are required to attend at the Marquee Matches booth on the Event date in-person, at a time no later than that stipulated in the Instagram DM to you. Selected Participants who are late will be disqualified automatically.

Meeting of matches

12. Proposals for matches are made by representatives of Marquee. Please note these parties are not professional matchmakers and Marquee Matches is not a matchmaking service. No warranties or guarantees are provided as to the suitability or success of the potential matches, or any outcome, or that any proposal put forward will satisfy all of your preferences or requirements.
13. Selected Participants will be provided the opportunity to meet your proposed match before you enter the Ferris Wheel together. You may at any time decide not to enter the Ferris Wheel with the proposed match, in which case your participation in Marquee Matches will come to an end and another participant may be selected.
14. Please note your interactions prior to entering the Ferris Wheel, in the Ferris Wheel and after you exit from the Ferris Wheel will be filmed. You may also be asked questions about your experience. You will be required to sign a Filming Release prior to entering the Ferris Wheel. Please do not make a submission for Marquee Matches if you do not wish to be interviewed or filmed.
15. All participants are required to treat each other with courtesy and respect at all times. You agree not to harass, or cause a nuisance, inconvenience, distress or anxiety to, or violate the privacy of, any other party.

Responsibility and liability

16. By participating, you accept full responsibility for your personal interactions and understand that MBS and Marquee cannot be held accountable for the actions of others. MBS and Marquee are not responsible or liable for any interactions that may occur during or following the Event, including any unwelcome or inappropriate contact or behaviour from the other participants.
17. To the maximum extent permitted by law, you agree to release MBS and its affiliates, advertising and promotion agencies, representatives, agents, successors, assigns,

employees, officers, and directors from all liabilities that might arise from: (i) your submission of the Form or Card; and (ii) your participation in Marquee Matches.

Personal Data Processing

18. By submitting a Form or Card:

a) **Collection, Use and Disclosure of Personal Data**

You consent to MBS and/or its agents and third-party service providers (whether located in Singapore or elsewhere) (collectively, the “**Parties**”) collecting, using and disclosing your personal data submitted in this form or collected by the Parties pursuant to the Event for the following purposes:

- (i) organising, administrating and conducting the Marquee Matches. This includes (without limitation) assessing your submission, identifying or shortlisting potential match(es) for you, facilitating Marquee Matches activities during the Event and/or contacting you regarding event matters;
- (ii) where you are a Selected Participant, disclosing your personal data submitted in the Form or Card to your matched participant(s) and announcing you as the selected participant to the attendees at the Event;
- (iii) compliance with MBS’ internal policies, any applicable law/regulation and request/direction of any applicable authorities of any relevant jurisdiction that is binding on MBS; and/or

b) **Display of Personal Data at the “Marquee Matches Booth”**

You understand and agree that:

- (i) If you are a Selected Participant through the online submissions; or
- (ii) By submitting the Card on the day of the Event, the personal data provided in your Form or Card (as the case may be) may be displayed at a publicly accessible Marquee Matches booth at Marquee on the day of the Event.

You acknowledge that other attendees and third parties present at the venue may view, photograph or otherwise collect the displayed personal data, and that MBS cannot control or prevent such activities. If you do not wish to have your personal data displayed on the Marquee Matches booth, please do not make a submission for Marquee Matches.

c) **Photography and Publication**

You consent to the Parties taking photographs and/or video recordings of you during the Marquee Matches meetup session, including (without limitation) during your interactions prior to entering the Ferris Wheel, in the Ferris Wheel and after

you exit from the Ferris Wheel or when you share your experience with the Parties. You further consent to MBS using, publishing or posting such photographs and/or recordings on its websites, social media platforms or promotional materials for publicity and marketing purposes. If you do not wish to have photographs and/or video recordings of you being used for the aforementioned purposes, please do not make a submission for Marquee Matches.

d) **Withdrawal**
